New Home Occupational Tax Certificate Requirements:

Administration Fee \$25.00, This fee is nonrefundable and due at time application is submitted.

A Business License/Occupational Tax Certificate must be obtained before your business can open. Please be aware that it may take 7-10 business days for review once all paperwork has been received.

Required Paperwork

- Submit a completed Harris County Home Occupation Occupational Tax Certificate Application.
- Submit a completed Affidavit Verifying Status for County Public Benefit
- Submit a completed Private Employer Affidavit
- Submit a copy of your Driver's License (address must match the location address).
- Submit a current copy of your paid tax receipt.
- Submit Landlord Permission Letter (if applicable).
- Submit a copy of your State of Georgia Professional / Trade License (if applicable).
- Submit a copy of Georgia Department of Agriculture License (if applicable).
- Submit a copy of your Corporation Name / Status (if applicable).

Once the application has been approved, we will call you to let you know it is ready for pick up. You may pick them up Monday – Friday 8:00 am – 4:30 pm. You may pay cash, check or card, if you pay by card there will be a convenience fee (\$3 minimum fee for the first \$100 or 3% of the total if over \$100). If the certificate is not picked up within 30 days, the application will be voided, and a new application and application fee will be required.

All license/certificates run calendar year and expire December 31.

Please return all completed applications, forms, documents and/or required paperwork to Harris County Community Development.
