Private Residential Swimming Pool

Private Residential Swimming Pool Permit Requirements:

- A Copy of a recorded plat of property with the Clerk of Court's raised seal:
 - These documents are available in the Clerk of Superior Court Office.
 - **NOTE:** If the property was subdivided, created, or conveyed prior to December 21, 1982, then a copy of the recorded deed and a tax map of the property will serve as a substitute for the recorded plat.
- Site Plan:
 - Site Plan should show the house location and pool location and any other structures on the property.
 - Distance from pool and all property lines, house, and any other structures on the property.
- Health Department Approval
 - You receive this from the Harris Co. Health Department. It is located on GA Hwy 116 E, Hamilton, Georgia or call 706-628-5780.
- Copy of signed pool contract.
- Size and valuation of pool.
- Signed pool letters. (Pool letters must have original signatures.)
- Current copy of Pool Contractors Business License.

Private Swimming Pool Inspections

1. Electrical Grounding / Bonding Inspection (Electrical Permit for pool is required before inspection.)
2. Pool Final - For the final inspection of the pool it will need to be completed, alarms on required doors and windows and required fence installed.

REQUIREMENTS FOR PRIVATE RESIDENTIAL POOLS

2018 INTERNATIONAL SWIMMING POOL AND SPA CODE WITH 2018 GEORGIA AMENDMENTS

All swimming pool installations must be **FINALED**. The pool contractor is responsible for installing the permanent barrier/fence and required door and window alarms. It is illegal to fill the pool with water prior to installation of the permanent barrier. Fence materials and gates shall meet the requirements of the swimming pool code. All swimming pools shall be completely enclosed by a fence at least four (4) feet (1.2 m) in height. Openings in the fence or gate shall not permit the passage of a sphere four (4) inches (102 mm) in diameter. The fence shall be equipped with self-closing and self-latching gate(s). A three (3) foot clear zone is required around the outside of the barrier, i.e. no equipment, planters, benches or anything that creates a climbing opportunity. Doors and windows with direct access to the pool shall be equipped with an alarm which produces an audible alarm when the door or window is opened, and the alarm shall be listed in accordance with UL 2017.

HARRIS COUNTY ZONING ORDINANCE

1. Private swimming pools may be established in agricultural and residential zoning districts provided they are to be used by the occupants of the property on which it is (they are) located and their guests. No part of the swimming pool may extend into any required front yard in (an) agricultural zone or into any required front or side yard in (a) residential zone.
2. Swimming pools may be established in any zoning district. They may be located anywhere within the back yard of a residential zone based on topography. All noncommercial pools within a residential zone shall be enclosed by a fence or wall adjacent to the pool decking not less than four (4) feet in height. All commercial pools shall be enclosed by a fence or wall adjacent to the pool decking and not less than six (6) feet in height to prevent uncontrolled access.

*NOTE: All metallic parts (sides, railing, diving board, steps, lights, pumps, etc., and re-enforcing wire or other metallic parts) shall be bonded and grounded per 2020 Edition National Electrical Code, by a qualified state licensed contractor.
