- **Football**
  - Summer Flag Season happening
  - Fall Tackle and Cheer registration gearing up
  - Must have 3 forms of verification to register on website
- **Swim Team is practicing**
- **Man O'War Trail**
  - Phase 4 should start during Summer to beyond the country store
  - Phase 5 is starting plans to the current Middle School in Hamilton
- **Ellerslie Park Summer Camps**
  - Alexander Paving finished the road
  - County Crews and Park Crews are still working
  - Budget approved a new employee, vehicle, equipment, signage, and pavilion/storage
- **Summer Camps**
  - Day camps with YMCA are strong. 40 kids with 5 Counselors in Training (CIT), and 6 Counselors/week
  - Sports camp
    - Basketball CSU had 20 kids in June. Will have another one in July.
    - Football – Tae Crowder camp had 230 signed up
    - Cheerleading Clinic had 33 girls
    - Soccer CSU had 45 in June. Will have another one on July
    - Dance camp in July
    - Volleyball in July

- **Swim lessons will offer classes in June and July**
- **Adult Softball Summer League has 5 teams in each league (co-ed and men's)**
