- 1. **CALL TO ORDER**. Chairman Greenhaw called the meeting to order.
- 2. <u>MINUTES</u>. - B. Ratify Execution of Quitclaim Deed to Callaway Gardens re: Release of a Portion of Property Included in 2007 Tax Abatement. Following discussion, the motion to approve/ratify the execution of the Quitclaim Deed was made by Mr. King, seconded by Mr. Lange, and passed unanimously. - C. Ratify Execution of Warranty Deed to Knology re: 5 acres in Northwest Harris Business Park. Following discussion, the motion to approve/ratify the execution of the Warranty Deed was made by Mr. Smith, seconded by Mr. Lange, and passed unanimously. - D. <u>Updates of Various Projects</u>. Mr. Lange brought the Authority members up to date on various projects to include Daesol (in Northwest Harris Business Park), Smyrna Redi-Mix (purchased Xpress Materials business), Airport security fence, GDOT SR 103 accel/decel lane (near Northwest Harris Business Park), GDOT SR 219 passing lane, GDOT US 1/SR 27 passing lane (near Earl Davis business), GDOT Fortson Road Bridge, GDOT US 1/SR 27 widening, possible GDOT assistance regarding metal bridge over US 1/SR 27 (near old entrance of Callaway Gardens), ACCG's Board of Managers meeting at the Lodge & Spa in December 2018, the new Library, the need for Broadband, the Grove development, and use of the old Library building.
